- (c) To promote the education activities through establishment Institutes/college/school which will provide Good Quality education /Higher Education in B.Ed., Management, I.T., BPO, Marketing, Insurance, Health, Rural Development / Management, Journalism, Engineering, ITI, Pharmacy, Medical, Dental, Law and others as decided time to time.

- (u) To plan and arrange for modern research in Ayurvedic, Yunani, naturopathy, Manochikitsa and homoeopathic, System of medicine.

8) The Trustees shall be accountable only for such moneys and funds, which will actually come into their hands.

9) The Trustees will not be entitled to receive any remuneration, but the trustees may reimburse themselves all expenses actually incurred by them in connection with the trust or their duties relating there to.

10) The number of the trustees shall not be less than five and more than nine. If the number of the trustees shall fall below two, the trustees shall not expect for the purpose of filling any vacancy act so long number is below the said minimum.

11) The Managing Trustees for the time being will be liberty to appoint additional trustee within the number mentioned above for such period or on such terms as to retirement and re-appointment as the trustee for the time being considered properly.

12) A person can be a trustee either : -

(i) If he / she, without any leave of absence does not attend three consecutive meeting of the trustees or for one calendar year, whichever is longer,

OR;

(ii) If he/she, is requested to resign by 3/4<sup>th</sup> or as near thereto as possible of the remaining trustees.

13) Every Trustee will be at liberty to resign on giving one month's notice of its intention to do so.

14) The Trustees may from time to time frame rules for the conduct and regulations for the meetings to trustees. In the absence of such regulations: -

a) Two Trustees shall form a quorum for a meeting of the trustees.

b) The Trustees will decide all matters mutually.

c) Resolution passed without any meeting of the trustees but by circulation thereof and evidenced in writing under the hands of two-third of the trustees shall be as valid and effectual as a resolution duly passed at a meeting of trustees.

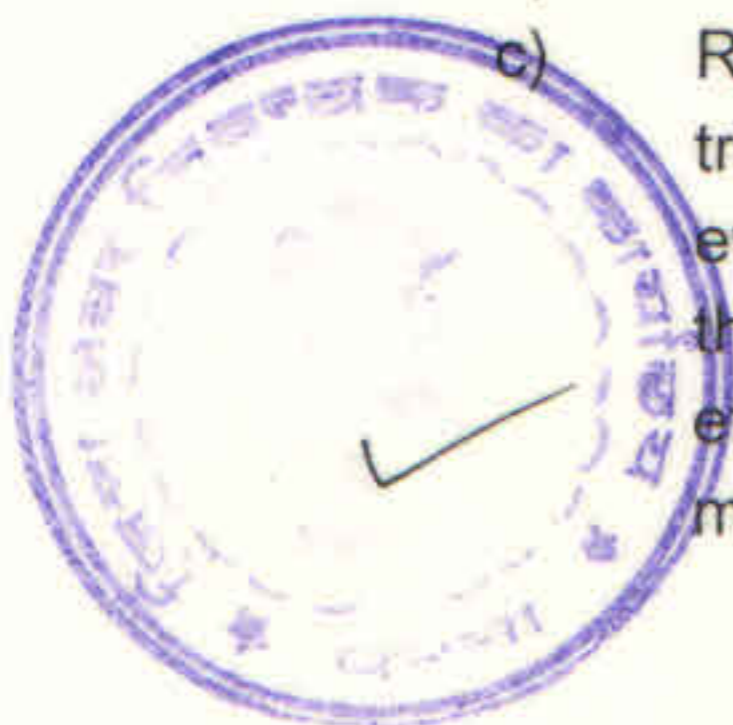

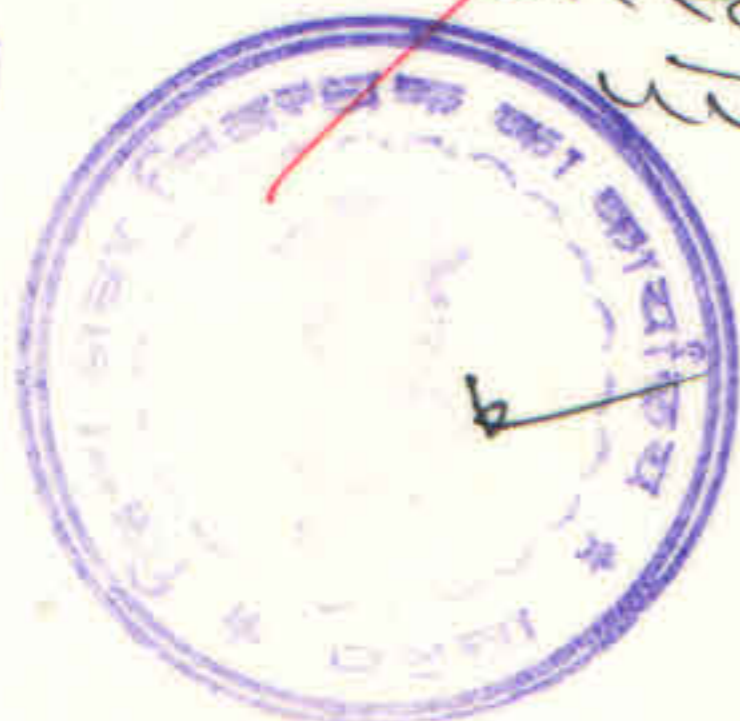
